

The minutes of the 14th meeting held on 20/05/2025 was forwarded vide Letter No. Trans.Cell/2025/423-447 dated 19/06/2025 where in it was decided to issue reminder to the remaining departments.

In view of above, it is again requested to take immediate necessary action to include 3rd gender column in all the official documents so that compliance of provisions in Transgender Person (Protection of Rights) Act, 2019 and Transgender Persons (Protection of Rights) Rules, 2020 be reported to the Ministry as well as to Supreme Court of India.
